5.02 RIGHTS OF A CHILD

Purpose Statement

The primary focus of Windermere's Family Day Care (FDC) Service is always what is in the best interests of the child and in doing so we honour the United Nations Convention on the Rights of the Child in all aspects of service delivery.

Scope

This policy applies to all salaried full time and part time staff (including casuals), educators, contractors, children and families.

Policy Statement

TO MAINTAIN AT ALL TIMES THE DIGNITY AND RIGHTS OF ALL CHILDREN BEING EDUCATED AND CARED FOR BY THE SERVICE.

Procedures

General

FDC staff & educators will treat children with courtesy, kindness, respect and equity.

Education and care services are inclusive of all children and based on the rights of a child and principles of social justice. That is, the right to fair and equal treatment regardless of age, gender, class, ethnicity, sexuality, geographic location, languages spoken, cultural background or current circumstances.

Convention on the Rights of the Child – Summary

Staff and educators will respect the rights of children as enshrined in the United Nations convention on the Rights of the Child and are committed to advocating for these rights. A summary of the United Nations Convention Rights of the child include (but are not limited to):

- 1. Every child has the right to privacy
- 2. Every child has the right to freedom of expression
- 3. Every child has the right to his or her identity
- 4. Every child has the right to education
- 5. Every child has the right to enjoy his/her own culture, to profess and practice his/her own religion and to use his/her own language
